What is Valid Nutrition Peanut Formula Ready-to-Use Therapeutic Food (RUTF)?

Ready-to-Use Therapeutic Foods are highly fortified, oil based nutrient dense pastes specifically for the treatment of severe acute malnutrition. The product is designed to be used as part of a structured programme of community-based management and not for retail sale.

The formulation of RUTF delivers the same nutritional qualities as the WHO's F-100 milk. Unlike F-100, RUTFs are not water based and require no further preparation. This has two main advantages:

- Bacteria cannot grow in RUTF hence it can be stored safely for up to one year without the need for refrigeration.
- * RUTF can be eaten directly from the pack and is safe to use in the home without medical supervision.
